### **DWARF Committee Membership**

The DWARF Committee is open to any individual or company interested in supporting the development and promotion of the DWARF Debugging Information Format, which is used to describe computer programs in multiple programming languages and how they are translated into machine languages, to support debugging and other analysis of such programs. The Dwarf Committee provides a source of information regarding the DWARF Debugging Information Format, and fosters communication between potential suppliers, customers of the resulting products, and potential members.

The DWARF Committee is comprised of two membership levels: Corporate Sponsor and Individual Supporter. Each Individual Supporter Member, while in good standing, shall be entitled to designate one voting representative and an alternate representative to vote on each matter submitted to a ballot.
